

Statement of Accounting Policies

Bike Manawatu Inc For the year ended 31 December 2017

'How did we do our accounting?'

Basis of Preparation

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Changes in Accounting Policies

Interest income has been recognised on an accrual basis, when previously it has been recorded on a cash basis. This change does not materially affect the performance report.

Specific Accounting Policies

In the preparation of the Performance Report, the specific accounting policies are as follows:

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Income Tax

Bike Manawatu Inc is not required to pay income tax as it holds an exemption from the Inland Revenue Department under Section CW41-43 of the Income Tax Act 2007.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Property, Plant and Equipment

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset. Where an asset is donated to the entity, its cost is measured at its current value as at the date of acquisition.

Depreciation is charged on a straight line basis over the useful life of the asset, except for land. Land is not depreciated. Depreciation is charged at rates calculated to allocate the cost or valuation of the assets less any estimated residual value over its remaining useful life:

Bikes: 10%

Plant and Equipment 10%-20%

Office Equipment 50%

Motor Vehicles 30%

Depreciation methods, useful lives and residual values are reviewed at each reporting date and are adjusted if there is a change in the expected pattern of consumption of the future economic benefits or service potential embodied in the asset.

The Board has not adopted any Tier 2 PBE Accounting Standards in the preparation of these accounts.

Donations, Fundraising and Other Similar Revenue

Donations received are included in operating revenue. If particular conditions are attached to a donation that would require it to be repaid if these conditions are not met, then the donation is recorded as a liability until the conditions are satisfied.

Donated goods or services are not recognised.

Grants received are included in operating revenue. If particular conditions are attached to a grant that would require it to be repaid if these conditions are not met, then the grant is recorded as a liability until the conditions are satisfied.

Receivables

Receivables are stated at their estimated realisable value. Bad debts are written off in the year in which they are identified.

Provisions

Provisions are recognised when the entity has a present obligation (legal or constructive) as a result of a past event and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.



13. Prior Period Correction

2017: Nil 2016: The 2015 financial statements did not include a creditor for Traffic Management services that were undertaken in the 2015 financial year. This resulted in the expenses for the 2015 year being understated by \$4,150, the creditors understated by \$4,773 and the GST liability overstated by \$623. This opening balance of accumulated funds has been adjusted in the current year to reflect this error.
